Another important part of the evening is the public election for one Board of Supervisor seat. Details on how to vote appear below.

How to Vote For a Board Supervisor

An Election of a Board Supervisor of the Richland Soil and Water Conservation District will be held in accordance with Chapter 940.04 of the Ohio Revised Code. One (1) supervisor will be elected to a three-year term beginning January 2020.

<u>Board Supervisors</u> serve without pay. The Board of Supervisors create an annual and long-term plan of operation that protects the District's vision and participate in monthly board meetings, assist with programs and attend area and state meetings.

Residents or landowners, firms and corporations that own land or occupy land in Richland County and are 18 years of age or older may vote for supervisors. A non-resident landowner, firm or corporation must provide an affidavit of eligibility, which includes designation of a voting representative, prior to casting a ballot.

Absentee voting started Thursday, October 17, 2019. You have two ways to vote via absentee ballot:

- Stop in our office Monday through Friday from 8:00 a.m. to 4:00 p.m. and complete the <u>SEL-2 Form Request</u>
- Once the SEL-2 Form is complete, mail it or bring it to our office. Our address is 1495 W. Longview Avenue, Suite 205B, Mansfield, OH 44906.

Absentee ballot requests must be received at our office by October 31, 2019.

Completed absentee ballots must be received in our office by November 7, 2019, at 3:00 p.m.

You may also vote at the Annual Celebration on November 7, 2019, from 5:00 to 6:15 p.m.

Milkweed Seed Pod Collection Continues Until Nov. 7



We are getting many milkweed seed pods and we thank everyone who has collected and dropped them off. There is still plenty of time to collect, so if you haven't started yet, it's not too late. If anything, the season seems to be a little behind.

When collecting, look for pods that appear slightly gray and are dried out before picking. Seeds inside should be brown before harvesting. Please

remember, if you want to pick on private property, you need to ask for permission first.

Last year's massive statewide seed collection effort was spearheaded by the Ohio Pollinator Habitat Initiative (OPHI), which is working to get the word out about why monarch butterflies are disappearing and help partners create monarch habitat. The disappearance of milkweed, the only host plant for monarch caterpillars, across the U.S. has contributed to the 80% decline of the eastern monarch butterfly population over the last 20 years: http://ow.ly/ncwE30fwsKC

Collect the pods in a brown paper bag and drop them off at our office in the green and yellow container. During winter, the seeds will be removed from the pods and we will distribute them for planting. We support saving the Monarch Butterfly and the Ohio Pollinator Habitat Initiative and know you do, too!

Tech Corner

Tech Corner is the section in the E-Newsletter that we answer questions from residents and contractors who work and build here in Richland County.

Q: How Do I Know Which Soil Types Are On My Property?

A: Great question! USDA-NRCS has a simple yet powerful online tool which you can use to access soil data information called the Web Soil Survey (WSS). You can



access the home page for the WSS at this link: https://richlandswcd.net/services/soil/soil-in-your-backyard. Once you've successfully navigated to the site, the home page provides some basic information on the WSS and has some helpful links if you want to get more in-depth information about soils or need help using the WSS tool. Also on the home page is a quick overview of how to use the soil survey tool. The site breaks it down into four basic steps, but first you'll want to click the green button that says "Start WSS" or click on the "Start Web Soil Survey" link under the I Want To... sidebar. After clicking Start WSS, you'll first need to define your area of interest (AOI). Under the Quick Navigation header is a drop-down arrow next to address which you can click on and enter the address of the property that you'd like to know soils info for. The program will then zoom to the area of

the entered address. Once you've navigated the program to the property you're inquiring about, you'll need to define the area of interest by selecting the AOI rectangle and trace out the area you're interested in on the Area of Interest Interactive Map. The program will then create the AOI and highlight the selected area in blue with diagonal lines shading in the AOI. After successfully defining your AOI, you'll want to select the Soil Map tab next to the Area of Interest (AOI) tab. This is where you'll find a breakdown of the different soil types located within your defined area of interest. From here you can print the information by selecting "printable version" in the upper right-hand corner of the window. A pop-up window will then appear where you can name the map and then select the view option in the lower right-hand corner of that window. A new tab will then be created in your web browser where a map of your AOI and a map unit legend with the breakdown of the soil types in your AOI can then be printed. If this seems too complicated or if you'd like assistance interpreting the results of the WSS please call us to set up a demonstration time and we'll be more than happy to help!

Intern Application Deadline Extended to November 22





This Month's Only Rain Down the Drain Tip

Storm Drains and roadside ditches eventually lead to our inland lakes and the Ohio River.

Compost your yard waste:

- 1. It will add nutrients to the soil.
- 2. Introduces valuable organisms and microorganisms such as bacteria to the soil.
- 3. Allows for yard waste and kitchen waste to be recycled.
- 4. Reduces wasted space at your local landfill.
- 5. Composting is good for the environment.
- 6. Composting and then adding to your soil will help reduce acids and alkaline levels in your soil



Soil Test Before Winter

In order to have good, healthy, productive plants you must start with fertile, healthy soil. Good soil retains water, releases nutrients and drains well. It must contain adequate nutrients, optimum pH and organic matter to be healthy and fertile. Guessing about additives for your lawn, garden or farm field usually means too little or too much fertilizer gets added. Too little fertilizer may result in healthy





plants. Too much is wasteful and can threaten our lakes and wetlands. Also, soils vary within the state, your neighborhood, and even your yard or farm field. What may be good for your neighbor or brother's lawn, garden or farm field may not be right for yours.

With winter approaching, some critters may try to get inside your home to escape the weather. Here are some tips from ODNR-Div. of Wildlife about how you can manage them properly:


