

# H20hio Voluntary Nutrient Management Plan Fact Sheet

## What is H2Ohio?

H2Ohio is Governor Mike DeWine's comprehensive, data-driven water quality plan to reduce harmful algal blooms, improve wastewater infrastructure, and prevent lead contamination.

The Ohio Department of Agriculture is leading efforts to reduce phosphorus runoff. Producers can receive incentives for implementing proven, cost-effective best management practices on their land.

### **Livestock Producers**

Livestock Producers will likely need a Comprehensive Nutrient Management Plan (CNMP) written. Please contact your SWCD to determine if a CNMP is needed.

# What is A Voluntary Nutrient **Management Plan?**

A Voluntary Nutrient Management Plan (VNMP) is the gateway practice for H2Ohio and will be required to participate in the other agricultural cropland practices.

#### **How It Works**

Producer agrees to develop and implement a Voluntary Nutrient Management Plan consistent with ORC 905.31(DD).

VNMP can be developed by 4R Certified Dealer, Certified Crop Advisor, or Producer.

Producer submits completed VNMP to SWCD for review and approval.

Producer submits nutrient application records annually for review by SWCD.

#### **Benefits for Farmers**

Nutrient recommendations based on current soil tests and Tri-State Fertilizer Recommendations.

Producer may apply for up to 4 years funding.

## **Frequently Asked Questions**

How long is Voluntary Nutrient Management Plan valid? A plan is good for a maximum of 4 Years for a VNMP to meet soil testing requirements. Soil tests and recommendations may need to be updated.

Do I need a soil test?

Yes. Soil tests are required and must be no more than 4 years old.

When taking new soil tests, how must they be done to remain in compliance?

Soil tests should be consistent with how the producer plans to implement their nutrient management plan. If a producer is implementing variable rate phosphorus, they will need precision soil tests to reflect management grids or zones. Who can write a Voluntary Nutrient Management Plan?

A VNMP can be developed by a 4R Certified Dealer, Certified Crop Advisor (CCA), or producer.

#### **Cost Share Incentive**

H2Ohio participants will receive \$10/acre upon approval of the VNMP from the SWCD. Producers may apply for additional H2Ohio funds to implement nutrient management plans after approval of the VNMP by the local SWCD.
